

## **Humboldt Trails Council Strategic Plan 2024 – 2028**

### I. About the Humboldt Trails Council and its Strategic Plan

#### **About the Humboldt Trails Council**

The mission of the Humboldt Trails Council (HTC) is to serve as a unified voice to support development, maintenance, connection to and use of trails for recreation and transportation throughout Humboldt County. As of late 2023, the organization consists of 11 board members, six Volunteer Trail Stewards (VTS) Trail Crew Leaders, and one part-time Trail Coordinator. There are approximately 100-120 volunteers, many of whom regularly show up to maintain, build, and otherwise support local trails throughout the year. The HTC sends out a regular e-newsletter and supports a website, Facebook page, and Instagram account. The Council's primary ongoing expenses are insurance and operating expenses for Trail Stewards at the many work sites, our e-newsletter, support to partner non-profits, and incidental expenses for special events. The council has been extremely active in advocating for the formation of the Great Redwood Trail and the railbanking of the railway. The Humboldt Trails Council is a 501(c)3 organization.

#### **History of the Humboldt Trails Council**

The Humboldt Trails Council was founded in 2004 and was initially called the Trails Trust of Humboldt Bay. In 2010 it became the Humboldt Trails Council, primarily for two reasons: (1) it wished to focus on supporting trails in communities throughout Humboldt County, and (2) the term "trust" has a legal meaning that was not accurate for this organization. For many years, HTC was a membership-based organization and had one part-time staff person. In 2015 it ceased to have any paid staff and was unable to provide membership "perks" or coordinate renewals. HTC continues to accept donations but does not track memberships. This plan outlines some of the options for engaging future supporters.

Since 2015, the Humboldt Trails Council Board of Directors

- has held monthly meetings.
- formed board committees to carry out the strategies and actions as directed through the board. Standing committees include Advocacy and Volunteer/Community Engagement. The committees meet separate from the regular board meeting and report back to the board. Each board member is part of at least one of these sub-committees.
- developed MOUs with the City of Arcata, City of Eureka, County of Humboldt, McKinleyville Land Trust, and Northcoast Regional Land Trust.
- have a part-time VTS Coordinator to oversee and organize the VTS operations.
- expanded the VTS program to include 11 trails that are routinely maintained.
- recruited VTS volunteers through a presence at local events.
- increased volunteer activity in the VTS program with over 6000 hours of volunteer work to maintain local trails in 2023.
- hosted several volunteer recognition events to thank volunteers and provide recognition items to them.

- purchased a Kubota Flail Mower and Eco-Counters as tools that can be utilized by trail organizations.
- responded to needs for trail-related advocacy and representation in the community.
- strongly advocated for formation of the Great Redwood Trail, rail banking the corridor, No Coal in Humboldt, McKay Community Forest, Humboldt Bay Trail, etc.
- developed a website that supports communication with volunteers and supporters.
- communicated via a quarterly e-Newsletter (over 1000 subscribers) that shares information regarding local and regional trails, photographs, and trail experience opportunities.
- held periodic Trail Summits in collaboration with other trail partners to inform the public about trail development, trail-related legislation, trail programs, etc.

### **About this Strategic Plan**

This Strategic Plan is an update to the previous five-year plan (2018-2023). The document outlines what our board of directors believes to be achievable objectives for the next five years. The plan was developed with two primary methods of input: (1) responses from a Stakeholder Input survey emailed to partners in July, 2023 (see all comments received in Appendix A), and (2) input from our current board of directors.

#### II. Strategic Plan Narrative and Implementation Schedule

Our primary goals in the next 5 years are to:

- 1. Advocate for development of trails, active transportation, trail connectivity, and trail amenities. Share information about local trails, needs, and calls-to-action. Maintain and expand website, continue quarterly e-Newsletter, and provide "Calls-to-Action" to the trail's community when necessary.
- 2. Support the Volunteer Trail Stewards (VTS) program to provide ongoing building and maintenance of trails and trail networks. Continue support for the Trail Stewards program, grow the VTS program where support exists, support the Trail Crew Leaders, recruit and utilize support from HTC volunteers for non-VTS activities.
- 3. Encourage safe trail use for recreation and transportation in Humboldt County. Partner with groups that work directly with people of color (POC), persons with disabilities, seniors, women, the LGBTQ+ community, and youth. Engage youth in volunteerism and trail experiences. Continue to support local governments to identify trail accessibility needs and opportunities. Inform the public of maps of local trails using an easily accessible web-based platform, continue use of social media and messaging.
- 4. **Ensure organizational capacity to accomplish HTC mission:** Improve board and volunteer recruitment, improve the website to support communication with supporters, conduct fundraising, consider "membership" options and models, continue development of board member "jobs" beyond executive officer roles, maintain and improve relationships with community partners, and host an annual meeting.

## **Support for VTS**

## **All Responses**

If you could pick only one new thing that HTC would accomplish in the next five years, what would that thing be? What are the immediate BIG NEEDS to support and promote trails in Humboldt County?

- Support the CR trail as much as we can.
- New thing: Collaborate and learn from other Trail Councils. Big Needs: promote Mckay Community Forest as venue for volunteers.
- Encourage more community members to volunteer to maintain trails.
- Co-branding that highlights the trail opportunities in each area.
- Inform trail-supporters on how to support trail building (e.g., opportunities for letters to elected officials, support letters, pressure when needed, trail maintenance, donations, being informed etc.).
- Help create and connect to the Great Redwood Trail!

- Partner with Green Diamond Resource Company to allow hiking and biking on private GDRC lands via a permit system (as they do in WA and OR).
- Ensure Great Redwood Trail build out in downtown Eureka and from Eureka to CR
- Sustain volunteer trail stewards at existing trails and promote new VTS sites for the Bay Trail South and Arcata Annie & Mary Trail
- Educate the local community on the potential effect of climate change/sea level rise on local trails.
- Establish and maintain outreach to inform public about VTS in the community
- Support and advocate for the maximum extent of the Great Redwood Trail throughout the county!
- Build the Humboldt Bay Trail Endowment Fund to \$1,000,000 to support volunteer activities. It (it's) already at \$500,000!
- Continue to grow capacity for maintaining and expanding Trail Stewards projects
- Bring existing trails up to **State safety standards**.
- I have two things that are on my mind . . . they are somewhat related. Many of the trail maintenance needs in Six Rivers NF, some BLM properties, and some State Park properties have been very neglected. Is there capacity to expand our trail maintenance support to include some of these trails? These may make more sense to be done by a volunteer trail crew working for a weekend or a week . . . generally a 2 3 hour work day will not cut it. It would be worth talking with the Bigfoot Trail Alliance about either collaboration or learning from the BFTA experience. The second item is to collaborate with the Bay Trail Fund Committee to take advantage of new milestones on the Bay Trail and the Annie & Mary Trail to reinvigorate the fund raising effort and, perhaps, work to expand the scope of the endowed Fund (what can it be used to support).
- County Parks and Recreation need more staff to manage their many (and ever growing) responsibilities. Is there anything HTC can do to support that need, recognizing the county currently is in the red?
- Generating more volunteer numbers for each event and location.
- One idea is helping to create a pathway for young people (especially in high school and college) to become actively involved in trail initiatives. Facilitate the next generation. Maybe sponsor a scholarship or internship to serve on the council board or some other position? Another idea is to expand opportunities for people to IDENTIFY as a trail support and lover. As humans we have a natural affinity to feel connections as members of a group. VTS volunteers feel this through working with others. The trail summit supports this outcome as well. Are there additional programs or initiatives to reinforce a sense of group belonging? For example, distributing materials with HTC name and logo, or considering becoming a membership organization.

## What can our Board do to improve access to trails for new or underrepresented users?

- Publicity!
- Reach out to schools or organizations to promote Humboldt County Trails.

- Find out which user groups are underrepresented and do targeted advertising and provide guided tours to those users.
- Advocate for the connection of the Annie & Mary Trail between Blue Lake and Glendale.
- Build reciprocal relationships w/ advocacy groups/advocates for those users
- Meet them where they are- connect with them to find out what they are interested in.
- Facilitate school field trips with a program of discovery. The kids will educate the parents.
- Partner with organizations that are doing equity work, particularly related to outdoor recreation & transportation, and support them in their needs
- Advocate for more trails that directly connect to neighborhoods, seek to expand community representation on the HTC board, collaborate to provide more trail information in Spanish.
- Table at Friday Night Market. Promote website, Newsletter, Facebook and Instagram.
   Maps too!
- Participate in public events where underrepresented users might learn of the program.
- Social media promotion of different trails and how to get info about them.
- School field trips, local service clubs planning events on the Trails, Churches and other existing networks.
- Trails in every community
- safe parking, safe trails, more publicity, room for horse trailers
- I think access is pretty good.
- Work with First 5 Humboldt to support the use of Hiking Humboldt Kids . . . First 5
  Humboldt has access to families from underrepresented trail users. More liaison with
  Cal Poly students and student organizations . . . where the student population is far
  more diverse than the surrounding community . . . as hike leaders, trail stewards,
  interns.
- Provide Spanish translation on humtrails.org website. Continue efforts to outreach in neighborhoods with diverse populations, markets, Cal Poly Humboldt, etc.
- Collaborate/host events with groups such as Latino Outdoors, Black to the Land, etc. Highlight accessible trails for those with disabilities.
- Reach out to local Chamber of Commerce's with an information sheet about HTC and Trail Stewards program.
- One potential role is to facilitate communications from people with physical disabilities who are trail users, back to trail managers, regarding what features they like and don't like about local trails and how these trails could be improved. This effort could be coordinated with Tri-County Independent Living.

# Where do YOU go to get local trail updates now? How can HTC improve its communication with the public?

# What should be the geographic scope of HTC's activities? Is there a priority area within this whole area?

- We've always been focused pretty much on the Humboldt Bay area; I don't see that changing.
- Stay local, stay focused on Eureka trails and McKay
- Humboldt county with Eureka, Arcata, Fortuna and McKinleyville as the priority region
- Trails create connectedness between communities; highlight all of it!!!
- County? Prioritize trails that have highest potential of getting people to drive less.
- all of Humboldt County
- Now that we have trail projects in the works for the north-south coastal corridor, prioritize
  connecting the dots between Arcata and Redding/Red Bluff. There's been latent
  demand for east-west routes for decades, and virtually no progress there. We should be
  looking at utility right of ways, as well as fire roads, forest service roads, etc. to define
  through east-west routes.
- Priorities should focus on either (a) areas with greatest potential for public use, or (b) areas with a historic underinvestment in trails

- Where there is community energy within Humboldt County...likely more focused in the Humboldt Bay region
- Humboldt County, with a focus on Eureka, Arcata and Fortuna
- Hard to consider is static geographic area, as HTC has possibility of linking with more trails. As long as these trails are supported by volunteers, they will be part of our geographic area.

- Perhaps a greater focus on equity improving access to safe active transportation facilities as well as access to nature for underrepresented groups - would be helpful

#### What are the difficulties and challenges of your trail?

- Trash from homeless people. Vandalism. Litter.
- County Parks Staff and Sheriff's office needing more personnel to make a presence and keep up with the work necessary. On the Hammond itself, abandoned camps/dumps, loose dogs, vandals (graffiti and property), invasive plants, 5 miles of trail with adjacent parks and facilities needing maintenance.
- For Eureka Waterfront North, it is convincing EPD to work for more directly with us.
- We're getting great participation at McKay CF. There will be a need for VTS work on the new Humboldt Bay Trail segment near the end of 2024.
- Although the focus on our trail is ecological restoration, trash is the biggest challenge to the trail. It is never ending and can't be completely combated by volunteer days. We are just a band-aid on a bigger issue.

## Please provide any additional ideas, comments and suggestions you may have for HTC.

- Change the title from "Trail Coordinator" to "Trail Crew Leader" "Coordinator" is confusing, because "Coordinator" is Rachael's title.
- I will say that the HTC, VTS, and support for trails has grown so much in the past half dozen years. The leadership of the HTC has been wonderful . . . thank you for all of your efforts.
- Thank you HTC for your wonderful support of the Trail Stewards and regional trails advocacy!
- Thank you for all the volunteer work and being so effective serving our community.
